Deptt.'s has sanctioned administrative approval for the programme and authorized Commissionerate of Rural Development, Gandhinagar to release the grant (Read at Sr. No.4) for the year 2008-09. The CRD released partly grant. Now the commissioner of Rural Development, Gandhinagar is supposed to release remaining grant **Rs.17.06 Lakh**. The Commissioner, Rural Development, Gandhinagar, Gujarat State is pleased to release State share of **Rs.1706000/-** i.e. (Rs.
